#### Milan Institute of Cosmetology-Vacaville

Pursuant to the federal *Student Right-to-Know Act*, on an annual basis, Milan Institute of Cosmetology determines and makes available an overall graduation rate of certificate or degree-seeking, first-time, full-time, undergraduate students. In addition, Milan Institute of Cosmetology also provides the Student-Right-to-Know graduation rate disaggregated by various sub-categories, as determined and defined by the U.S. Department of Education.

The Student Right-to-Know graduation rate is based on a "cohort study," meaning that a group or "cohort" of students is identified and then monitored over a period of time. The current rates, set out below, are based on the group of students who enrolled for the first-time, as full-time students, between September 1, 2018 and August 31, 2019. The rate represents the number of those students who earned their degree or certificate within 150% of the normal time required to complete their program. The rate does not include students who left school to serve in the armed forces, on official church missions, or in the foreign service of the federal government. Students who died or were totally and permanently disabled also are excluded.

It is important to note that the Student Right-to-Know graduation rate is calculated at the school level. In other words, there is one rate for the entire school, not a rate for each specific program. Certain institutions also are required to calculate and distribute graduation or completion rates for students receiving athletically related student aid, as well as transfer-out rates. These requirements, however, are not applicable to Milan Institute of Cosmetology. Milan Institute of Cosmetology also makes available each year a federal retention rate, which is the percentage of first-time, full-time students from the previous fall who are still enrolled, or successfully completed their program, the following year. Like the Student-Right-to-Know graduation rate, this retention rate is based on a cohort study and calculated at the school level (i.e., there is one rate for the entire school, not a rate for each specific program). The current rates, set out below, are based on the group of students who enrolled for the first-time, as full-time students, between August 1, 2020 and October 31, 2020 and who were still enrolled or completed their program as of Fall 2020.   - c. Is not subject to denial pursuant to Section 480 and
  - d. has done any of the following:
    - 1. Completed a course in cosmetology from a school approved by the board or;
    - 2. Practiced cosmetology, as defined in this chapter, outside of California for a period of time equivalent to the study and training of a qualified person who has completed a course in a cosmetology from a school the curriculum of which complied with requirements adopted by the board. Each three months of practice shall be deemed the equivalent of 100 hours of training of qualification under paragraph (1) of this subdivision or;
    - 3. Holds a license as a barber in California and has completed a cosmetology crossover course in a school approved by the board *or*;
    - 4. Completed a barbering course in a school approved by the board and has completed a cosmetology crossover course in a school approved by the board *or*;
    - 5. Completed the apprenticeship program in cosmetology specified in Article 4 (commencing with Section 7332).
- Earber license, The board shall admit to examination for a license as a barber to practice barbering any person who has made application to board in proper form, paid the required fees, and is qualified as follows:
  - a. Is at least 17 years of age;
  - b. Supplies proof of successful completion of the 10<sup>th</sup> grade in California or its equivalent;
  - c. Is not subject to denial pursuant to Section 480 and
  - d. has done any of the following:
    - 1. Completed a course in barbering from a school approved by the board.
    - Completed an apprenticeship program in barbering approved by the board as conducted under the provisions of the Shelley-Maloney Apprentice Labor Standards Act of 1939, Chapter 4 (commencing with Section 3070) of Division 3 of the Labor Code.
    - 3. Practiced barbering as defined in this chapter outside of this state for a period of time equivalent to the study and training of a qualified person who has completed a course in barbering from a school the curriculum of which complied with requirements adopted by the board. Each three months of practice shall be deemed the equivalent of 100 hours of training for qualification under paragraph (1).
    - 4. Holds a license as a cosmetologist in this state and has completed a barber crossover course in a school approved by the board.
    - 5. Completed a cosmetology course in a school approved by the board and has completed a barber crossover course in a school approved by the board.
    - 6. Completed comparable military training as documented by submission of Verification of Military Experience and Training (V-MET) records.

  - c. Is not subject to denial pursuant to Section 480 and
  - d. Has done any of the following:
    - 1. Completed a course in nail care from a school approved by the board.
    - 2. Practiced nail care, as defined in this chapter, outside of this state for a period of time equivalent to the study and training of a qualified person who has completed a course in nail care from a school the curriculum of which complied with requirements adopted by the board. Each three months of practice shall be deemed the equivalent of 100 hours of training for qualification under paragraph
    - 3. Completed the apprenticeship program in nail care specified in Article 4 (commencing with Section 7332).

#### INFORMATION ABOUT THE BEAUTY INDUSTRY

Hair designers and those who practice cosmetology and barbering work mostly in salons, but may work in a spa, hotel, or resort. Those who practice nail technology and aestheticians work mostly in salons and spas but may work in a hotel or resort. Some lease booth space from a salon owner, and others manage salons or can open their own shop. Instructors work mostly in a school but may teach at a training salon. Physical stamina is important, having to be on your feet for most of the time. Prolonged exposure to some chemicals may cause skin irritation, so they often wear protective clothing, such as disposable gloves or aprons.

Employers look for the following traits when hiring hair designers, cosmetologists, barbers, nail technologists, and aestheticians: (1) Creativity by keeping up with the latest trends and trying new hairstyles for clients; (2) Customerservice by being pleasant, friendly, and able to interact with customers in order to retain clients, as well as listening carefully to what the client wants; (3) Tidiness by keeping a neat personal appearance, and the work area clean and sanitary. This is necessary for clients' health and safety so they will be comfortable and want to return; and (4) Timemanagement is important in scheduling appointments and providing quality service, so clients trust that you are dependable.

The state of California requires 1,000 hours for the barbering and cosmetology program and 400 hours for the manicuring program. The extra 200 hours in manicuring is not required for licensure but is required to complete the program. Program completion is required by the state to sit for the license exam.
